GENERAL INFORMATION:

Brief description

Nomax® 150 SC is a broad-spectrum Insecticide for the control of Fall Army worm (*Spodoptera frugiperda*) in maize. The active ingredient Teflubenzuron inhibits chitin production during cuticle development in insect juvenile stages. Failure of the cuticle to develop fully causes death during the molting process. Best performance will be obtained in the pest infestation as a preventive treatment or as a curative treatment to young larvae stages.

Alphacypermethrin is a non-systemic insecticide that acts on adults, larvae and has significant ovicidal and repellent effect. It has a very good Knockdown effect and persistence of action. Alphacypermethrin sustains succession of the nerve impulses which leads to over stimulation, exhaustion, and death of the insect. Alphacypermethrin belongs to the pyrethroids chemical Class in the IRAC Group 3A, Teflubenzuron is a chitin synthesis inhibitor belonging to the Benzoylureas chemical class in the IRAC group 15.

Mixing instructions:

Half fill the spray tank with water. Add the required amount of Nomax® 150 SC then fill the water to the required level and mix or agitate thoroughly to uniformity. Spray immediately after mixing.

Direction for use

Crop	Pest	Application, Rate, spray volume /20L	Timing & frequency of application
Maize	Fall armyworm	200 ml/ha Or 20 ml per 20 L of water Use spray volume of 200 L per hectare.	Start the application when you notice the first symptoms of the attack on the leaves (beginning of scraping). Repeat the application when there is reinfestation of the pest at the recommended dose. Apply a maximum of 2 sprays at 14 days interval.

Pre-Harvest-Interval (PHI) : Maize 45 days

Re-Entry Interval (REI): 24 hours, unless wearing protective clothing.

RESISTANCE MANAGEMENT:

"Repetitive/continual use of Nomax® 150 SC can lead to pesticide resistance. It is recommended that Nomax® 150 SC is alternated with pest control products with a different MODE OF ACTION as well as adhere to good farming practices".

HAZARD/SAFETY PRECAUTIONS:

Harmful if swallowed. Do not breathe vapour/spray. Ensure thorough ventilation of stores and work areas. Use personal protective clothing. Avoid contact with the skin, eyes, and clothing. Use Suitable chemical resistant safety gloves, Safety glasses, with side-shields, apron, protecting boots, chemical-protection suit. When using do not eat, drink or smoke. STORAGE:

DISPOSAL:

Nomax® 150 SC ni kiuadudu kinachotumika kudhibiti wadudu wa aina ya 'Fall Armyworm' kwenye mahindi. Teflubenzuron huzuia umbaji wa wadudu hiyo basi kusababisha kifo wakiwa viluwiluvi. Unapotumia Nomax® 150 SC anza kunyunyizia mimea yako mapema kabla ya wadudu kuonekana na hatia pia wakati hawaajaonekana wakiwa viluwiluvi na wadudu wakubwa.
