DIRECTIONS OF USE IN PINEAPPLES

Siege® Pro is a granular insecticide bait used in controlling ants in pineapples. It contains hydramethylnon which belongs to the chemical class trifluoromethyl aminohydrazone. As the formulation contains an oil which turns rancid upon prolonged exposure to air, it is recommended that the product be fully used within three months after opening container. Being a slow-acting stomach insecticide, broadcast **Siege® Pro** granular insecticide using ground equipment (spinning disk or turbine types) after ant infestation levels have been determined.

Rate and Timing of application

HANDLING PRECAUTIONS

1. Wear long sleeved shirt and long trousers, PVC gloves and shoes.
2. Avoid contact with skin, eyes and clothing.
3. Wash thoroughly with soap and water after handling.
4. Keep out of ponds, lakes streams and other water sources as the product is toxic to fish.
5. Do not apply if it is likely to rain one hour after application.
6. Do not feed animals with any treated green chop (leaves/stems) for at least 6 months after last application.
7. Do not expose to air due to risk of rancidity. If opened, use within 3 months at the latest.
8. Do not eat, drink or smoke while handling this product.

STORAGE: Store in a cool dry well ventilated place, keeping the original unopened container tight-ly closed, away from food/feedstuffs, children, pets, sources of heat and oxidizers.

WASTE DISPOSAL

1. Empty the containers completely by thorough shaking.
2. Destroy empty containers to prevent reuse and burn them in a suitable incinerator or bury them in an approved dump site away from natural water source complying with local regulations.

LEAK AND SPILLS: Wear protective clothing as outlined above. Sweep up with spill control mate-rial or suitable absorbent material e.g. sand, sawdust or general purpose binder. Clean contami-nated floors and objects thoroughly with water and detergents.
